HEAD START SERVED A TOTAL OF 262 PRESCHOOL CHILDREN AND EARLY HEAD START SERVED A TOTAL OF 114 INFANTS AND TODDLERS AND 7 PREGNANT WOMEN DURING THE 2017-2018 SCHOOL YEAR. UNDER THE PROJECT UTILITIES PROGRAM, 625 FAMILIES RECEIVED ASSISTANCE DURING THE FISCAL YEAR.
